



THE MELBOURNE AGREEMENT FOR THE PROSECUTION AND PUNISHMENT OF THE MAJOR WAR CRIMINALS OF THE AUSTRALIAN AXIS

WHEREAS:

- A** By the Grace of God, in the Year of Our Lord, One thousand and Ninety, the Christian Cavelliers founded the Sovereign Military Order of the Knights of Justice, to preserve the Voice of God through Natural Reason as the ancient liberties and free customs of the British People.
- B** By the Grace of God, in the Year of Our Lord, One thousand Nine Hundred and Ninety-Nine, H.R.H. Prince Joseph of Ponderosa succeeded H.R.H. Prince Bernhard of The Netherlands as the Royal Protector of the Knights of Justice; and the Principality of Ponderosa replaced The Netherlands as the Royal Protectorate of the Order.
- C** By Declaration made upon the seven hundred and seventy-seventh anniversary of the signing of the Great Charter by King John at Runnymede, H.R.H. the Prince of Caledonia did recite that the Governments of Victoria, New South Wales and the Commonwealth of Australia were de facto governments.
- D** By Proclamation made the 28th day of June, in the Year of Our Lord, One thousand Nine hundred and Ninety-five, H.R.H. the Prince of Caledonia did acknowledge and confirm that the Crown in Right of the Colonies of New South Wales, Victoria, South Australia, Queensland, Western Australia, Tasmania and the 'Commonwealth of Australian' had abdicated government; that the de facto governments of the Colonies of New South Wales, Victoria, South Australia, Queensland, Western Australia, Tasmania and the 'Commonwealth of Australia' had been dissolved by operation of law, and that on and from that date, the citizens of the Colonies and the Territories comprising the 'Commonwealth of Australia' had been absolved of any allegiance thereto.
- E** By Proclamation made the 6th day of August, in the Year of Our Lord One thousand Nine hundred and Ninety-five, H.R.H. the Prince of Caledonia did create the Duchy Bank of Albany, now known as the Royal Bank of Caledonia, with powers to create constitutional money and give it currency, inter alia, to fund the prosecution and punishment of the major War Criminals of the Australian Axis.

- F** By Proclamation made the 25th day of December, in the Year of Our Lord, One thousand Nine hundred and Ninety-five, H.R.H. the Prince of Caledonia, as the chosen Viceroy of Almighty God to restore constitutional government to the People of Australia, did appoint H.R.H. the Prince of Runnymede, H.R.H. the Prince of The Highlanders, H.R.H. the Prince of The Hebrides, H.R.H. the Prince of Brougham and H.R.H. the Prince of Ausfreeborough as joint Governors of the Colonies of New South Wales, Victoria, Queensland, South Australia, Western Australia and Tasmania, and the Territories comprising the ' Commonwealth of Australia ', with powers to provide for the peace, order and good government thereof, as allowed by law.
- G** By Proclamation made the 6th day of September, in the Year of Our Lord, One thousand Nine hundred and Ninety-eight, H.R.H. the Prince of Caledonia, as one of the Patriarchs of the House of Israel, did found the Commonwealth Bank of Britannia, with power to underwrite currency created by the Royal Bank of Caledonia.
- H** By Treaty made the 26th day of April, in the Year of Our Lord, One thousand Nine hundred and Ninety-Nine, the aforesaid joint Governors caused the Colonies of New South Wales, Victoria, South Australia, Queensland, Western Australia, Tasmania and the Territories comprising the ' Commonwealth of Australia ' to form a Treaty Nation named the United States of Australia.
- I** By Treaty made the 26th day of September, in the Year of Our Lord, One thousand Nine hundred and Ninety-Nine, between the Principalities of Caledonia, Marlborough, Ausfreeborough, The Hebrides, Runnymede, Brougham, The Highlanders, and Ponderosa, and the Commonwealth of Britannia, the Parties thereto did:
- (a) acknowledge, confirm, ratify and make good the aforesaid Declaration and Proclamations made by H.R.H. the Prince of Caledonia, and the Treaty Creating the United States of Australia,
 - (b) acknowledge, confirm, ratify and make good various Proclamations annexing the National Estate of Australia made by the Principalities of Caledonia, Marlborough, Ausfreeborough, The Hebrides, Runnymede, Brougham, The Highlanders and the Commonwealth of Britannia, between the 27th day of May, in the Year of Our Lord, One thousand Nine hundred and Ninety-three and the

sixth day of September, in the Year of Our Lord, One thousand Nine hundred and Ninety-eight, and made provision for the National Estate of Australia to be held in trust for the People of the Australian Colonies and Australian Principalities,

(c) cause the Principalities of Caledonia, Marlborough, Ausfreeborough, The Hebrides, Runnymede, Brougham, and The Highlanders to form a Treaty Nation named the Commonwealth of British Israel,

(d) authorise the Royal Bank of Caledonia, underwritten by the Commonwealth Bank of Britannia, to create money and to give it currency as a pledge against the National Estate of Australia to fund the exercise of powers conferred upon the Ministers of State of the United States of Australia.

J Before the de facto governments of the Colonies of New South Wales, Victoria, South Australia, Queensland, Western Australia, Tasmania, and the 'Commonwealth of Australia' (hereinafter referred to as the Australian Axis) abdicated government; government instrumentalities, government officials, public and private corporations and private persons, committed acts of war against the citizens of the Australian Colonies and the Australian Principalities, being actual or constructive military, police, political, spiritual, economic, social, cultural, racial and propaganda acts of war, in contravention of the Laws of God, the Laws of Nature, the Laws of the Constitution and the Laws of Humanity,

K After the Australian Axis abdicated government, the Axis continued to assert sovereignty over the citizens of the Australian Colonies and Australian Principalities as foreign powers imposing foreign law, and purported government instrumentalities, purported government officials, public and private corporations and private persons, continued to commit acts of war against the citizens of the Australian Colonies and the Australian Principalities, being actual or constructive military, police, political, spiritual, economic, social, cultural, racial and propaganda acts of war, in contravention of Laws of God, the Laws of Nature, the Laws of the Constitution and the Laws of Humanity.

L By the London Agreement made the 6th day of August, in the Year of Our Lord, One thousand Nine hundred and Forty-five (known as the Nuremberg Convention), the Governments of the United Kingdom, the United States of America, the Republic of France and the Union of Soviet Socialist Republics, representing the Peoples of the United Nations, constituted an International Military Tribunal and made provision for the prosecution and punishment of the major War Criminals of the European Axis.

M The sacred cause of Justice dictates that the Government of the United States of Australia, as the interim government representing the citizens of the Australian Colonies, the Government of the Commonwealth of British Israel, representing the citizens of the Australian Principalities, and the Government of the Royal Protectorate, should constitute an Australian Military Tribunal and make provision for the prosecution and punishment of the major War Criminals of the Australian Axis.

NOW THEREFORE, We

The Crown and de jure Government of the United States of Australia,
The Crown and de jure Government of the Commonwealth of British Israel,
and The Crown and de jure Government of the Principality of Ponderosa,
Humbly relying upon the blessings of Almighty God,

DO HEREBY AGREE as follows:

Article 1

There shall be established an Australian Military Tribunal for the trial of War Criminals whose offences are geographically related to the Australian Colonies and Australian Principalities, whether they be accused individually or in their capacity as members of organizations or groups or in both capacities.

Article 2

The constitution, jurisdiction and functions of the Australian Military Tribunal shall be those set-out in the Charter of the Australian Military Tribunal, which shall be agreed upon by the Parties to this Agreement.

Article 3

The war crimes to be tried by the Australian Military Tribunal shall include the contravention of such principles of domestic and international law as shall be agreed upon by the Parties to this Agreement.

Article 4

The Government of the United States of Australia shall conduct a public and private awareness campaign to acquaint the citizens of the Australian Colonies and the Australian Principalities with the aforesaid principles of domestic and international law, and invite them to submit case histories for consideration by Prosecutors appointed for the investigation of the charges against the War Criminals.

Article 5

Any Government of the United Nations and any Government of an Australian Principality may accede to this Agreement by notice given through the diplomatic channel to the Government of the Royal Protectorate, who shall inform the other Parties to this Agreement and acceding Governments of each such accession.

Article 6

Nothing in this Agreement shall prejudice the lawful exercise of jurisdiction or powers over War Criminals of the Australian Axis by the General Assembly of the United Nations, the Security Council of the United Nations, the International Court of Justice, the International War Crimes Tribunal or the United Nations Human Rights Commission.

Article 7

The Parties to this Agreement hereby severally appoint H.R.H. the Prince of Barrecourt, as Minister Plenipotentiary to each of the Governments being the Parties to this Agreement, with power to lodge this Agreement with the United Nations Organization and its Members, and to treat with that Organization and its Members relating to the implementation of this Agreement.
